Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. Description of School Parental Involvement Plan

As a reminder, we will send additional copies of the plan to all parents in August. Parents can also retrieve a copy of the plan in the Parent Resource Center and Main Office.
