## Atlanta Public Schools Chattanooga TN Highlights

October 20-21, 2016

Trip #10550

This tour to Tennessee will take students on an educational adventure of Lookout Mountain. To the very top via the Incline Railway and over 1100 feet below the surface for a visit to Ruby Falls. A guided tour will allow students to look and study beneath the Earth's surface ... Stalactites and Stalagmites, and other geological formations all lead to the thundering 145 foot historic waterfall that has been thrilling visitors since 1929. Students will also take a ride on the Incline Railway. The Incline's trolley-style cars climb through the natural beauty surrounding historic Lookout Mountain at a breathtaking 72.7% grade – straight up! Sit back, and enjoy the scenic views of the mountains and valleys from the observation windows on the train as well as the panoramic views from the observation tower at the Incline's top station. The following provides more information on the tour.

## CANCELLATION

The deposit as listed on the flyer is non-refundable should a traveler cancel up to 4 days before the trip date. If a trip is cancelled within 3 days of the tour 50% of the trip cost is non-refundable. All other payments will be refunded through Kelly Tours should a student have to cancel for any reason. Written notice must be sent to notify Kelly Tours of cancellation and the refund will be mailed out.

## GENERAL INFORMATION

A final letter will be sent to participants highlighting departure and return times, important phone numbers and arrangements, what to bring and an updated schedule of the trip.

## WAIT LISTS

Kelly Tours buses accommodate 56 passengers (including the chaperones and escort). Availability on all motor coach tours is based on a first come first serve basis. If space is not available, the traveler will be put on a waiting list. An additional bus may be added to the trip (at the discretion of the school and Kelly Tours) if the waiting list exceeds 20 people by the final payment date. Sign-ups with initial or full payment made after the final payment date will not be guaranteed space on the trip, and, in most cases, will not be processed.
