- 13. Floor was open to vote for swing seat; motion made to table election by Felicia Josey in order to meet candidates (Brown & Crowder) in person; motion denied.
- 14. Motion made to move forward with swing seat election by (Brodie, 2nd by Triplett); elections proceeded.
- 15. Swing seat candidate Justin Crowder was voted in 6 in favor: 1 not favored); candidate Erika Brown 6:1 not in favor 1 favored
