Who Needs to Quarantine After Exposure to a Positive Case?

Who Doesn't Need to Quarantine After Exposure?

- People who are not vaccinated and have been in <u>close contact</u> with someone who has COVID-19.
- People who develop symptoms again within 3 months of their first bout of COVID-19.

- People who have had COVID-19 within the past 3 months or <u>who</u> are fully vaccinated and not <u>experiencing any symptoms</u>.
- People who have tested positive for COVID-19 within the past 3 months and recovered do not have to quarantine or get tested again as long as they do not develop new symptoms.
- Note: Persons exposed to other persons who have been exposed do not need to quarantine.

### What Counts as Close Contact?

- Close Contact through <u>Proximity and Duration of Exposure</u>: Someone who was within <u>6 feet of an infected person</u> (laboratory-confirmed or a <u>clinically compatible illness</u>) for a cumulative total of 15 minutes or more over a 24-hour period (for example, three individual 5-minute exposures for a total of 15 minutes). An infected person can spread SARS-CoV-2 starting from 2 days before they have any symptoms (or, for asymptomatic patients, 2 days before the positive specimen collection date), until they meet criteria for <u>discontinuing home isolation</u>.
- Exception: In the K–12 indoor classroom setting, the close contact definition excludes students who were within 3 to 6 feet of an infected student (laboratory-confirmed or a <u>clinically compatible illness</u>) where both students were engaged in consistent and <u>correct</u> use of <u>well-fitting masks</u>; and other <u>K–12 school prevention strategies</u> (such as universal and correct mask use, physical distancing, increased ventilation) were in place in the K–12 school setting. This exception does not apply to teachers, staff, or other adults in the indoor classroom setting.

### How Long does the *Quarantine* Last?

- In collaboration with Fulton County Board of Health, Health Services will advise on how long quarantines should last, based on local conditions and needs.
- School Nurses will address individual student and staff exposure cases. Whole class and Whole School exposures will be addressed by the Health Services Director.
- Students/Staff may return from quarantine:
  - After day 10 without testing
  - After day 7 after receiving a negative test result (test must occur on day 5 or later)
  - After stopping quarantine, individuals should continue to watch for symptoms until 14 days after exposure.

## Day One APS: Division of Schools SY21-22 District Quarantine Instructional Guidance

### **CONDITION A**

AN ENTIRE CLASS IS QUARANTINED DUE TO COVID CASES/EXPOSURES (INCLUDING TEACHER)

### **CONDITION B**

- ONE OR MORE STUDENTS TEST POSITIVE FOR COVID (UNRELATED CASES)
- ONE OR MORE STUDENTS TEST POSITIVE FOR COVID WITH EXPOSURES TO OTHER STUDENTS WITHIN A CLASSROOM/TEAM/GRADE LEVEL

A school has positive cases in different classes where there are no exposures within the spaces these students occupied

#### Example:

Teacher A – one student with COVID Teacher B – two students with COVID Teacher C – no students with COVID (Isolated cases throughout the building) A virtual or building-level designee will be assigned to deliver instruction virtually.

- Teachers will make current academic work available virtually. A teacher/tutor will provide after school tutoring for students absent during the quarantine period. Designated virtual teachers/tutors and number of tutorial sessions will be determined by school-level administration based on need.
- A virtual learning tutorial schedule will be developed by the school and implemented over the course of the quarantine period.
- Students who complete virtual assignments will be marked present.
