- AVA Direct (K-5)coincides with the district's bell schedule since its instructional model is synchronous instruction (all students receive instruction from a teacher at same time)
- AVA Flex (6-12) is accessible 24 hours/day-7 days a week as instruction is asynchronous. Virtual Instructional Specialists are available to assist AVA Flex students during school hours although they can access their course material at any time.

Students chosen in the lottery will receive access to a Parent Orientation session for more information about the AVA programs aligned with student grade level.

11. What does a typical day look like for an ES student?

Students K-5 will sign on virtually with their teacher for all core content. They have one Specials Rotation each day.

Lunch is 30 minutes and done off-line with whomever is supervising them at home. (same for all)

12. What classes can an ES student take?

AVA Jr. offers core content in ELA, Reading, Math, Science, and Social Studies in Grades K-5.

We also offer Music, Art, PE, and Media as our Special Rotations.

Gifted Services are provided within the teachers classroom, there is no "pull-out" for gifted.

All students also participate in the district-wide intervention/acceleration block.

- 14. What is AVA Flex? How is it different from F2F?
  - AVA Flex is being offered for 6–12 grade students.

- AVA Flex is a full time academic program in which students progress through and complete their course(s) using the pacing calendar within their learning platform. This program is done at the students pace but has fixed deadlines.
- AVA Flex differs from AVA Direct (F2F) in the instructional model (asynchronous vs. synchronous). AVA Flex students access their material via a learning platform accessible to them at any time. AVA Direct students receive instruction on a bell schedule and meet via Zoom classroom facilitated by teachers.
- AVA Flex students receive content help from Virtual Instructional Specialists by appointment during school hours.
- AVA Direct students receive content help from their F2F teacher.

15. What are the school hours for AVA Flex?

There are no set school hours for AVA Flex. Students are allowed to set their own daily work schedule. Students must work every day that school is in session, but may choose to work in the morning, afternoon, or evening. Virtual Instructional Specialists are available to assist students during school hours by appointment.

• Lessons and instructional activities are delivered within the learning platform. Students log into the learning platform and access recorded lessons, complete quizzes, tests and assignments everyday. Virtual Instructional Specialists are available during specified hours for course support.

16. What core classes can be taken in AVA Flex?

AVA Flex offers a variety of core content classes at the general level with many also at the honors and AP level. We also offer several CTAE, and World Language options. However AVA Flex does not offer:

17. Will 9-12 AVA students be given needed courses/credits and be on track for graduation? Zoned school counselors will audit individual transcripts before enrolling students to ensure the courses given are the courses needed. This will include courses needed for credit recovery and initial credit courses.

20. How do I schedule a K-5 student in AVA Jr.?

The SIS team will schedule K-5 AVA Jr. students.
21. How do I schedule a 6-12 student in AVA Flex?

The zoned home school counselor will use the Genius platform to enroll students into each
course during each grading period.
22. Are Charter Students eligible for AVA Jr, AVA Direct 6-12 and AVA Flex.?
(same for all)
Yes, charter school students are eligible for the AVA Jr. program. All families will need
to follow the application process.
23. Will lunch be provided for students who enroll in Atlanta Virtual Academy?
No. Lunch is not provided.
24. Can Special Education students attend AVA Jr.?
(same for all)
Yes. Interested families will need to have an IEP with their home school team and AVA
personnel.
25. Can Special Education students attend AVA Flex?
(same for all)
Yes. However, if you choose this model this may impact the accommodations that can be
offered. An IEP meeting will need to be scheduled to determine if this model is
appropriate to meet students' needs.
26. What if a child is not enrolled in school?
You will need to enroll your student at your zoned school. Zoned schools and AVA must
be made aware when students have moved outside of APS district. Students will need to
be withdrawn from their school and any APS equipment returned.
27. What if my student lives outside of Atlanta?

29. What are the actual priorities for registration?

Priority 1: APS neighborhood students not enrolled in an APS school and want a virtual learning option.

**Priority 2: APS students who are determined to be medically fragile with a signed form from their physician.** 

**Priority 3: APS neighborhood students currently enrolled in their APS school but want to transition into virtual learning.** 

Priority 4: Charter schools student who want a virtual option

30. Will there be a lottery for seats? If so, when will it be?

If the number of applications for a given grade level exceeds the number of available spaces, a random lottery will be conducted to provide each interested student with an equal chance to be admitted.
