



Student Benefits

Dual Enrollment is a program that provides funding for students at eligible high schools to take approved college-level coursework for credit towards both high school and college graduation requirements.

To recognize the additional effort required of students who enroll in Dual Enrollment (state funded or self-pay) courses taken at an accredited postsecondary institution, 10 points will be added to the final numeric grade for each course above that is passed with a grade of 70 or above.







How Much Does It Cost To Participate?



- Funding for Dual Enrollment is covered by the GA Student Finance Commission.
- The approved award rates to be paid for Tuition, Mandatory Fees, and Book costs are annually published.
- Dual Enrollment funding is available up to the student's high school graduation or home study completion date or the 30 semester or 45 quarter hours Funding Cap, whichever occurs first.



What type of student is a good fit for ACCA's Dual Enrollment Aviation Pathway?

ACCA's Aviation program is a rigorous accelerated pathway

Students must:

- Have a specific pathway planned for graduation
- Remain committed to attending class daily
- Stay organized and complete tasks as required
- Be responsible
- Have good behavior
- Be Self-motivated
- Be Mature
- Take initiative
- Meet college Dual Enrollment admissions requirements as specified



Admission Criteria For Aviation Maintenance Pathway



Students must be in the 12th grade during 2024-2025 school year and on track to graduate

HOPE GPA 2.6 or higher

ESOL/SST/504/Special Education (IEP) – If yes, team must meet to confirm eligibility to participate, and the student must contact ATC's Disability Office for support.

Total credits earned

4 ATC credit hours = 1 high school credit

Aviation Maintenance Pathway "Fall 2024 and Spring 2025"

General Aviation Maintenance Courses - Year 1

Fall Semester 2024 Dual Enrollment Courses

- AVMT 1011 Aircraft Maintenance and Regulations 4 credit hours
- AVMT 1021 Aircraft Applied Sciences I 5 credit hours

Spring Semester 2025 Dual Enrollment Courses

- AVMT 1026 Aircraft Applied Sciences II 4 credit hours
- AVMT 1031 Aircraft Electricity and Electronics 5 credit hours

Total credits earned

18 ATC credit hours = 4 high school credits



General Aviation Maintenance Pathway – After High School

Aviation Maintenance (2 TCCs)

- Airframe TCC
- Powerplant TCC

After completing the General courses, students will:

- Receive a completion certificate from ATC.
- Sit for FAA test for General
- Apply for either the Airframe or Powerplant TCCs at ATC



ACCA Aviation Pathway Next Steps For Students

Application Process:

After the meeting, staff member from ACCA and ATC will be available to assist students with completing:

- 1. ACCA Application
- 2. GA Futures Application
- 3. Atlanta Technical College Application

Students must complete all three applications by Friday, March 15th
