

APS has partnered with HealthCheck to aid our district in the task of collecting daily health screenings for students. HealthCheck is a health screening tool available as a mobile app and website, and on March 22, 2021, all APS schools will shift to use HealthCheck as the primary daily student health screening tool. HealthCheck will aid the district in not only mitigating the risk of COVID exposure, but will also provide school-level data regarding screening use, and the number of health screening fails.

All parents of students who declared that their child would return to learn in-person beginning Quarter 3, will utilize HealthCheck to answer a handful of COVID-19 specific symptom related questions before students arrive at school. HealthCheck and use of daily health screenings help to ensure that students do not come to school when they present with COVID related risks or symptoms.

After parents respond to the screening questions, they will receive a green or red color status (see below) indicating their level of risk based on their responses.

Students who have a green color status will have their temperature taken upon entry into school and no further health screening is warranted. If a parent responds in the affirmative to any of the health screening questions or has one or more symptoms, the school teams will be alerted of the red color status, and the student is not permitted to come to school until cleared by the school nurse.

3/8/2021	School to send home printed Parent communication #1 AND HealthCheck Implementation - Parent FAQ
3/9/2021	Vendor sends user account and activation email to parents

3/10/2021	You are invited to participate in a live 1 hour product demonstration of HealthCheck and Q&A session. Attendance is Optional. See Zoom links below. <ul style="list-style-type: none"> • 11:30 AM Session (1hr) • 4:00 PM Session (1hr)
3/15/2021	School principals, or designee, complete and submit acknowledgement survey that administration teams have completed self-guided training.
3/15/2021	Vendor sends reminder email to parents
3/16/2021	School to send home printed Parent communication #2 AND the Facility code sheet for your cluster
3/17/2021 - 3/19/2021	Schools are encouraged to utilize the HealthCheck dashboard to determine which students have not enrolled into HealthCheck, contact parents to assess any barriers, and plan for how they will receive daily health screening data for that student
3/22/2021	APS-HealthCheck Go-Live Date
