### b. FY' 2021 Hutchinson ES budget

- a. Current Budget is approximately \$4,800,000
- b. Original projection of students was 366; With a rebuttal we reprojected at 390 students
- c. Last year, money was given for 4<sup>th</sup> and 5<sup>th</sup> grade to support textbook adoption (ELA); This year funds are diverted to middle schools for their textbook adoptions
