B. Georgia Milestones Math Data

This data is available on APS Insights.

Last year 14% of our grade 3 students, 11% of our grade 4 students and 14% of our grade 5 students scored proficient or above. However, an examination of the cohort median RIT data shows that when we compare 22-23 and 23-24 cohorts, our school showed growth.

C. Continuous Improvement Plan:

- i. **Needs assessment and goals** – one of our challenges is how to retain students and to service a transient student population.
- ii. **CIP and Strategic Plan priorities** – another challenge is our absenteeism/tardiness rates.

Strategic Plan Priorities and Updates – the strategic plan was briefly discussed. Our priorities and plan may need to be modified because we have a new superintendent and some of the district plans and goals will have changed. We need to bring the plan into alignment with them. The GO team will be discussing, revising and voting on our strategic plan priorities at our November meeting because we do not have a December meeting.

A. Principal's Report:

- i. **Security Grant Update** – The governor of Georgia, Brian Kemp, granted funding to each school district. APS has used some of this funding to expand our Centegix System, and the schools received individual grants of \$45,000. Due to our recent remodeling our school's physical plant is safer – we have good lighting, etc so we have used some of this funding for staffing.
