- a. Principal's Report
 - i. New furniture and stem lab
 - ii. Enrollment: down 375 to 314. Class sizes are good, but HHES owes \$279,279 back to APS.
 - 1. Ms. Wheeler trying to find ways to not lose teachers by adjusting the budget.
 - iii. Ms. Wheeler shared the strategic plan, which focused on reading and math proficiency, and whole child. She will be emailing it to the team.
 - iv. She then shared some Georgia Milestone data. Can see on APS insights. In comparison to other Title 1 and high poverty schools, only approximately 5 schools performed better than Hope-Hill.
 - 1. Also, on the Score v. Challenge index, Hope-Hill performed well over the regression line, and scored much better on the GMAS than our challenge index expected us to perform.



- v. CCRPI and Daily attendance went down, but our disciplinary actions have gone down significantly since 2018-2019. We feel that we were very impacted by the pandemic.
- vi. Data highlights were we currently sit but we shouldn't shy away from the data. We don't have good growth data due to missing some tests during the pandemic. Will have much better growth data going forward.
