- B. CCRPI Orientation with Larry Wallace (APS State Accountability Manager)
  - Provided an overview on the 2017-2018 CCRPI New Updates
  - Middle schools now have four categories instead of three: Content Mastery~30%, Progress~35%, Closing Gaps~15% and Readiness~20%
  - Indicators have been reduced to 11.
  - All exceeding the bar indicators have been removed; career lessons, portfolios, inventories and Individual Graduation plans are no longer a factor.
  - CCRPI points are now based solely on student performance
  - Lexile levels have increased for students (6<sup>th</sup>-997,7<sup>th</sup>,1045,8<sup>th</sup> 1097)

The team expressed concerns of the impact this will have on BMS students and staff. Team felt this was a "big" blow with NO prior warning. Ms. Crooms discussed having Mr. Wallace come back to BMS to explain the changes to staff as well as parents. Ms. Crooms stated that we must have parent buy-in in order to be successful with the upcoming changes.
