--Sports programs are up an running, including APS sports, PTA sports, and 6th grade intermural sports

--Clubs and our Sutton Musical are starting

--Curriculum Night/Open house has been postponed out of concern of staff and student health in consideration of high levels of community spread.

--Scheduling Principal coffees

--We are currently supporting Sylvan Middle School zooming into Quigley's Algebra 1
