- a. **Health & Safety Updates:** Principal Blasingame discussed back to school health and safety protocols. Some things discussed included water filling stations, increased cleaning protocols, and increase surveillance testing (twice a week) for staff.

- a. **Principal's Report:** Principal Blasingame reviewed several key things since school has started. Attendance is data was discussed. Right now daily attendance is at 88%. This is up from low attendance during virtual learning. School priorities included literacy and building capacity in teachers. Students who get surveillance testing is at about 25% of our student population.
