#### V. Information Items

- a. Principal's Report
  - i. Enrollment and Leveling Updates
    - 1. Estimated enrollment was 616; 94 student drop
    - 2. Total enrolment as of 11.15.2023 is 524; big impact on budget.
      - a. Question from Ms. Howe: "What could have caused the drop in the 94 students expected?" Could it have been a rezoning issue sending students to the Jackson Cluster?"
        - Principal Rogers stated that it could e a number of reason—transient students (they go where their parents go and with the rising cost of living in the



- areas of gentrifications, student may be moving further out of the city)
- ii. Principal Rogers stressed that we are a School of Student Choice; whereas the other schools are school of choice via vouchers or partnered schools.
- 3. Loss of Funding in an estimated 500,000.00 as decreased to about 125,126.93 using CARES.
  - a. CARES Funding has been used to make up the deficit.
  - b. Impact was seen to impact field trips, media cener improvements, etc.
- ii. Additional Information Items
  - 1. Funding will be available to hire a STE(A)M Coach for the 2024-2025 academic year.
