A. **Return + Learn Plan and Principals Report**

Ms. Powell discussed how we would be returning to school, per the Superintendent's Plan. It is likely that school would return (but is still based on what the COVID19 outbreaks are in our region) on October 19th for teachers and the first of our students (MOID, Autism, Special Needs, and ESOL) returning on October 26th, and the remainder in November. We are awaiting final decision from Superintendent.

Ms. Powell went on to say that D.M. Therrell HS is ready whenever it is determined that students can return to school. Our readiness includes PPE, signage, one-way transitions for hallways, stairways and entering and exiting the building.
