IV. Discussion Items

- a. **Spring 2025 MAP Scores:** Fall vs Spring math data score were broken down. Angela discussed the comparison of 9th grade math and reading scores from the spring and fall. She noted that the scores were not significantly different, and the data did not show the expected growth.

11th grade reading map scores were also broken down by domain for students
Findings: SWD and ESOL students' scores still lag behind with both being significantly lower in math than reading

More intense support in reading and math

- i. 2025-2026 School updates

Issues that have to be addressed before next year:

1. Cell phones (collecting phones)

Kasun: Mentioned adding during advisement the benefits/data of not having a phone in class.

Shepard: Added starting this school year.

Mitchell: Added teachers need to model this behavior.

Scott: Mentioned using school issued chrome books.

Parents with students agreed with using chrome books but chrome books don't work well.

2. Lunches

Teachers will vote on decision about 4 or 5 lunches. The cafeteria is too small to accommodate all students, so the school is considering moving back to 5 lunch periods despite teacher and parent concerns about shorter lunch times.

3. Student parking

For student parking, new cameras and license plate readers will be installed to monitor driving behavior.

4. safety and security at games

Suggestion: use parking permit money to pay for extra help with the games. Game goers should be using the parking deck and walking through the building.

5. **Start time for games that pull students out of class.**

Angela proposes pushing back game start times or potentially revisiting an earlier school start time, though there are concerns about both options. She plans to work with the athletic director to find solutions that minimize missed instruction time.
