# **MEETING MINUTES**

## Thursday, October 6, 2016

## Warren T. Jackson Elementary School Main Campus Media Center, 3 p.m.

- I. Call to Order: Zachary White, Chair, 3:13pm

### III. Discussion Items

The team discussed the opening for the community representative seat on the GO Team left by Paquita Austin's resignation. Mr. McBride presented possible options on who might fill this spot but no action was taken at this meeting. Mr. McBride will make a nomination at the November meeting and the team will vote at that time.

#### IV. Information Items

A. Renee Prevallet of Metro RESA made a detailed presentation about the CCRPI data for Jackson for 2014-15, including highlighting potential areas for improvement and setting forth the following goals for Jackson, which the GO Team will use to assist in the formation of a strategic plan:

Goal 1: Increase content mastery achievement in math for students in three different subgroups.

- Goal 2: Increase content mastery achievement in science for economically disadvantaged students.
- Goal 3: Ensure that Jackson earns the "easy" points that are available (for example through LRE, lexiles, career lessons, etc).
- Goal 4: Increase growth for all students, including high performing students.
- Goal 5: Decrease the gap between the lowest quartile at Jackson and the state average.
- Goal 6: Avoid losing points by doing site based data clean-up, completion of surveys, and increasing attendance.
- B. Mr. McBride provided a brief presentation on Jackson's IB status and our most recent review. Specifically, he discussed how our IB certification will likely affect the Challenge program and other "pull out" programs going forward. Mr. McBride will present this information to parents at the Coffee Talk on Tuesday, 10/18.
- C. Mr. McBride discussed the possibility of Jackson becoming a STEM-certified school and whether it would make sense to revisit the question of which grade levels should be in each building. The team discussed the possibility of creating a STEM Academy at the current Primary Campus location.
