A. PTA & Foundation Updates

Audrey went over Data Review: Financial Condition/Leveling, Milestone scores and MAP testing. Milestones data from the spring will not be used for comparison data. Milestones data from Spring 2022 will be baseline. Budget and leveling data not available now but will be available for next meeting. MAP testing will end soon and data will be presented at next meeting.

A. APS Charter Renewal Information

Some changes to Go Team makeup (staff members who are parents cannot serve on their employer school Go Teams in the parent seats); Go Teams must meet six times a year and at least 3 may be virtual. All meetings must be recorded.

Change needed to Midtown Cluster Signature Program, which is currently College and Career. The certification organization for College & Career is not operating and making approvals, so certification can't be done in timeline required. Ms Sofianos said discussions and decisions will be at the cluster level. Principals have been exploring STEM. The decision will be between STEM, STEAM, or IB.

Schools will need to update Strategic Plans, format will be different. Must be completed by December 2021.
