Discussion Items

Discussion Item 1: Review additional data discussed in the October 2020 meeting

Information Items

Principal's Report - Audrey went over Intervention Data. A total of 24 a. students are being served 2 days per week. Safety precautions are being taken. The students have temperature checks upon entry. Daily snacks and supplies are provided to the students. They averaging 20 students per week. Support staff is available for one on one support if needed. Audrey also went over withdrawal data. She gave a breakdown of 132 students that withdrew this year. Kindergarten is at 65% of the projected number of students, followed by First at 92%, Second and Third Grade are both above projected numbers at 101% each. Fourth is at 88% and Fifth Grade is at 79%. School wide we are at 87% of the projected number of students. Attendance data was also discussed. MES is at 98.8% Average Daily Attendance. 22 students, as of 12/8/20, fall below the 90% threshold. 32% of those 22 students are in Fifth Grade. Lisa had concerns about reaching additional students that may need support. Wendy, Lynn, and Marva explained how we reach out to students who we see need extra support. We meet with these students outside of their regular classroom sessions. Each team is setting up intervention in the way that works best with their grade level. Audrey will provide qualitative data next time we meet.



b. Go Team Role and Responsibilities Document; Review of questions asked about Go Team responsibilities. Lisa briefly discussed the GO Team orientation video and how helpful it was. She was wondering if we could post something like that on the Go Team website as information to others who may be curious as to what the Go Team's role is. Marva mentioned the handbook has a page with Go Teams FAQ. She was wondering if that was something that could be posted. Diane mentioned that there are other schools who have more information on their websites about what their Go Team do. We are free to update our website with additional information about the Go Team.

Announcements - Lisa went over what was discussed at the Grady Cluster Advisory Team Meeting. It was a district wide meeting. They discussed potential areas of interest including: Inman Building (what's happening), Facilities master plan (might be pushed off for a year), Cluster Wide Interventions (closing the gap, closing equity gaps), Cluster autonomy, Cluster specific models, signature programs, communication with cluster as a whole, coordinating fund raising using structure of Grady Cares
