### Point, Purpose, and Rationale

### Point, Purpose, and Rationale: 7 Considerations

The health and physical safety of students, their families, and staff are our priority considerations

While virtual instruction works for some individuals and families, it is a challenge for some, particularly emergent readers and special needs students

CDC and public health department guidance on reopening schools for face-to-face instruction has evolved significantly over the course of the COVID19 pandemic

#### Point, Purpose, and Rationale: 7 Considerations

THES wants to offer an equitable option for ALL families, regardless of declaration [ virtual or face-to-face]

THES serves AND employs the segment of the population most likely to contract and/or become ill from COVID19

Concurrent Teaching [face-to-face and virtual at the same time] causes extra stress for instructional staff and reduces effectiveness

THES wants to begin to address the perceived "learning loss" of emergent readers and other vulnerable students

#### CDC Recommended Considerations for resuming Face-to-Face Instruction

Begin by assessing levels of community transmission - Fulton County Data

CDC Indicators and Thresholds for Community Transmission of COVID-19

Total new cases per 100,000 persons in the past 7 days	0-9	10-49	50-99	>100

CDC Recommended Considerations for resuming Face-to-Face Instruction

From the CDC:

Success in preventing COVID-19 in schools begins with and is connected to preventing transmission in communities. Schools and communities must implement a layered approach that adheres to multiple mitigation strategies and adjust them as needed to reduce COVID-19 risk for students, teachers, school staff, families, and the community. In areas of low or moderate community transmission, the spread of SARS-CoV-2 infection in schools is low when consistent use of layered mitigation strategies is in place.

When communities implement and strictly adhere to mitigation strategies, the level of community transmission is slowed. This will in turn enable schools that are open for in-person learning to stay open and help schools that have not yet reopened to return to in-person instruction. The application and utility of these indicators are inextricably linked to both schools and communities following recommended mitigation strategies.

#### **Student Discipline**

All other responses to student disciplinary infractions will follow THES' commitment to restorative practices and the APS Student Handbook.
