It was moved by Eshè Collins and seconded by Cynthia Briscoe Brown to authorize the Superintendent to advertise a bid to borrow money and issue an official statement. Due to an anticipated delay in tax billings, the Atlanta Public Schools finance department recommends a Tax Anticipation Note (TAN) in the principal amount not to exceed \$120,000,000.00 and not to exceed an interest rate of 3% and a final maturity date, on which principal and interest will be paid, of December 27, 2019.
