IV. Discussion Items – FY'22 Budget Development

Principal Portee reviewed the FY'22 budget with the GO Team. The budget outlines having more staff on board to help students catch up and creating supportive intervention strategies. Positions include: 2 Social Studies teachers, 1 Science teacher, 2 Math teachers, 2 ELA teachers, 1 CTAE teacher, 1 Behavior Specialist, 1 PE teacher, 2 school resource officers, 2 World Language teachers, 1 Graduation Coach. There is also \$475,000 in materials and supplies. The Digital Bridge Grant was approved and will pay .4/.5 of the Ed Technology Specialist position.

Principal Portee gave the principal's report. Attendance data was reviewed with the team, as well as CCRPI Goal Attainment, the Failure Rate Action Plan, data for Off-Track students (which is decreasing), Ninth Graders and review of information regarding reopening.
