The discussion of team vacancies was open by Dr. Duncan. Two of the previously vacant positions were filled and left the staff and community member positions vacant. Dr. Duncan has also submitted his nomination for Staff Member (Mr. Dominico Kantor / Science Teacher). The discussion of proposed staff member was opened. Several members asked several questions about this candidate. A motion was requested to close the discussion and a vote was called. Mr. Kantor received a unanimous vote to serve as the Staff Member on the GO Team for the 2017/2018 school year term.

Dominico Kantor's vote for staff member was accepted by the GO TEAM.

Officer Elections

1. Secretary - Can serve one term and is eligible for an additional term as Secretary. Dr. Neely nominated Dominico Kantor to serve as GO TEAM secretary for the 2017/2018 term. Mr. Kantor accepted the nomination and the GO Team moved to vote for the nominee. The Team voted and Mr. Kantor received the unanimous vote to serve as GO Team secretary for the 2017/2018 Term.



### a) Review strategic plans

Amendments to the strategic plan were made:

- i) School priorities
  - Increase the test average in each of the EOC/GMAS tested subject areas by 10 or more points was changed to 5 points
  - Increase the graduation rate to 75% changed to "greater than 70%". Our rate is currently 69.1%. After we increase the rate to 70%, we will then look into raising the average by 5 points, to 75%.
  - "Federal Funding" was changed to "Maintain Federal Funding annually." "SIG" was removed from federal funding
  - "Striving Readers Grant" was changed to "Utilize Striving Readers Grant"

### ii) School Strategies

- "and pre/post assessment and data" was added to
   "Implement district wide benchmark assessment system.
- 7A Was amended to read as follows: "Maintain a school wide Teacher Mentoring Program for new staff to Douglass High School.
- 7B was amended to read as follows: Continue teacher and leadership recruiting process in January of the fiscal year.
- A prospective 7C was proposed: "Teacher Retention"
