- ii. Homecoming week and subsequent dance
 - 1. Friday, November 11, 2022
 - 2. Criteria were based on students involving their parents in schoolrelated events
 - 3. Excellent turnout
 - 4. This was the first middle school homecoming court
- iii. Coat drive with CIS and Macy's partnership
 - 1. Saturday, November 12, 2022
 - 2. Over 400 coats were distributed
 - 3. All participants that attended were given a coat
- iv. Virgin Atlantic/ Passport to change partnership
 - 1. Representatives from England reported to the school to work with our 7th-grade students.
 - 2. They are hosting:
 - a. Aeronautics competitions
 - b. Paper airplane competitions
- v. Partnership with SAVE institute
 - 1. Entered a partnership with SAVE institute which is a nontraditional male-only high school with an enrollment of approximately 30 students.
 - 2. Students from SAVE institute are mentoring 25 of Price's male students.
 - SAVE institute and Price MS has a goal to build a martial art program for Price's 25 participants, which is slated to begin in Spring 2023
- vi. APYes award
 - 1. GoTeam won an award for Excellence GoTeam
 - 2. The event was held on Saturday, November 6, 2022
 - 3. GoTeam members attended
- vii. Safety and security prank calls
 - 1. Approximately 2 weeks ago, a Price 8th-grade student called the school's front office and made threats.
 - 2. The 8th-grade student and a friend also called our feeder school, causing the schools to initiate a lockdown.
 - 3. There was no adult participation.
 - 4. Consequences are pending based on the district hearing.
 - 5. The incident shed light on the school's Internal and external communication protocol.
 - 6. Cluster is in the process of developing a robust internal and





external communication plan and a safety task force to review and modify our current policies.

- 7. The 8th-grade student received a check from TikTok due to the incident going viral.
