IV. Discussion Items

- a. **Discussion Item 1**: Strategic Plan and CIP alignment
 - i. Current Strategic Plan focuses on increasing proficiency on Georgia Milestones in Literacy and Numeracy.
 - ii. CIP plan based on needs assessment and MAP data. Drop in math MAP assessments and reading assessments, drop in CCRPI attendance as well. Overarching needs: Improve comprehension of informational texts, Improved tier one math instruction. Work on Whole Child Intervention to improve daily attendance. Monitoring progress through MAP, Learning Walks and observations
 - iii. Action plans: K-3 implement fundations (literacy curriculum) with fidelity, increase grade level informational text exposure, utilize content-based information to build background knowledge. Explicit vocab instruction.
 - iv. Numeracy: Provide professional learning instruction and more support
 - v. Attendance: WCI team gets together to monitor attendance, behavior, and intervention. Provide monthly attendance motivational activities.
- b. **Discussion Item 2**: Strategic Plan Updates
 - i. Change CARE team to Whole Child Intervention team
 - ii. Change the ADA (average daily attendance) to CCRPI Attendance to 87. 1 by end of 2025
- c. **Discussion Item 3:** Spring 2023 to Fall 2023 Growth
 - i. Working to improve reading through interactive read alouds, explicit phonics instruction.
 - ii. The district is really working to support instruction and create learning plans.
 - iii. SRS has been heavily focused on math because of the new math standards and being sure to address the needs of the students. Math instructional strategies, walk through observations, and teacher professional development opportunities to enhance real world use of math have been implemented to support this area of need.
 - iv. Google classrooms are available for enrichment opportunities in all areas of need, you don't need to be in the gifted classes to have access.
 - v. The MAP data tracks a student with the same RIT scores at the same time of the year. We were wondering how the MAP/Milestones data may be effected by the change in Math standards, will be watching to see.
