- I. Chair Alex Wallace called meeting to order at 7:42 a.m.
- II. Meeting protocols
  - a. Roll call
  - b. quorum present
- III. Discussion Items
  - a. Impact of potential leveling on Inman Middle School
    - i. 15 day mark enrollment was 1068 – would result in losing 2 core teachers and 2 extended core
    - ii. Has been a learning experience for principal new to APS
    - iii. we would lose a math position (that was currently filled by a long term sub)
    - iv. Yesterday enrollment was 1073 – will not lose a social studies teacher. Only set to lose one teacher (math position).
    - v. Do not want to displace anyone else but we do have a clerk who resigned. Sent msg to HR to move our budget money from the clerk to teacher. Also moving money from PD and stamps, supplies (non-personnel money) that can be moved. \$85,310 has been identified to be shifted in order to keep that math teacher.
    - vi. Morna - What is extended core – connections classes. When is the deadline? (September 11);
    - vii. Leveling document is going to change & Dr Maxwell will be on the committee
    - viii. Foundation has not committed yet to replacing the non personnel funds but will take up the issue for discussion. In general, Foundation has agreed that they can fund PD and supplies but not personnel. Those budget funds were not fully used last year.

- ix. Trailers may warrant additional staff depending on what the certificate of occupancy says
- x. \$150 staples per teacher, plus another \$150 from PTO. +- \$120 total in the supplies budget. Need chrome cart and a bauxlite or 2. Between 25-30 k
- xi. Tamara moved to vote to move the money from PD and supplies identified by Dr. Maxwell to staff allocations and then vote on amended budget at next regular meeting. Discussion : Morna – at some point shouldn't we be holding APS more accountable for serving children. Seconded by Michelle, unanimous.
