IV. Discussion Items

a. **Discussion Item 1**: Stakeholder Engagement at School

The team discussed strategies to increase parent and community engagement.

Ideas included using paper bracelets and stickers as reminders for parents,

creating a QR code linked to a form for input and suggestions, and sharing school
information through community QR codes on Next door and at local Pre-K

programs. The team also considered reaching out to volunteer organizations to
strengthen community connections.

V. Information Items (add items as needed)

- a. **Principal's Update-** Dr. Toney shared some of the great things we have been doing at SPARK including gardening on the rooftop garden, STEAM tasks, and 3rd grade already had their first in school field trip. See presentation for photos. At the date of our meeting we have 422 students enrolled and had 412 projected.
 - i. District's Personal Electronic Device Policy- APS's PED policy is to have personal electric devices up and away. There is a board policy that aligns with a new state law that will be implemented in the 26-27 school year. This policy includes smartwatches, phones, tablets, and headphones.
 - ii. **Our PED implementation** SPARK's policy is that phones and smartwatches should be "Away for the Day." If a student needs to



contact a parent they can go to the front office and use the telephone. If a parent needs to contact a student they can contact the front office.

b. APS Forward 2040- Comprehensive Long-Range Facilities Plan Task Force Update

Task Force member Katy Allen provided an update on the group's work. She explained the process the task force has followed to review data, explore options, and engage in planning conversations. She also shared how stakeholders can access information about the Long-Range Facilities Plan. Draft options are expected to be available during the week of the 18th. A public meeting is scheduled for August 25.
