## II. Discussion Items *(add items as needed)*

- A. **Discussion Item 1:** Phase II Re-Opening: Pre-K – Grade 5- Return to school date is October 26, 2020. Students will attend school 4 days a week – Monday, Tuesday, Thursday, and Friday; Wednesday will be an asynchronous day for students. The school building will undergo deep cleaning on Wednesdays. Parent surveys for Grade 3-5 will be sent to parents. Parents will have the choice of selecting virtual, face-to-face or the Atlanta Virtual Junior Academy. Parents must commit to their selected model for their child until January 2021. Since the District has added Grade 3-5, they will send out surveys to teachers again in regards to their preference of teleworking or face-to-face.
- B. **Discussion Item 2:** Technology: Ms. Jenkins made a donation on behalf of Active Youth Academy in the amount of \$6,000. **Amendment to Ms. Jenkins' donation: Ms. Jenkins' made a donation on behalf of Active Youth Academy in the amount**

**\$5,000 not \$6,000.** Also, Cleveland Avenue Elementary received a \$10,000 donation from Elizabeth Baptist Church. Students were provided with Chromebooks, Ipads, and resource kits at the beginning of the school year.

C. **Discussion Item 3: Amendment to add the Election of Officers in the first meeting (September 30, 2020) minutes.**

**Election of Go Team Officers – Chair, Vice Chair, Secretary and Cluster Representative.** Dr. Payne read the qualifications and responsibilities of each office. First, Mrs. Richardson nominated Mrs. Bolden to serve as Chair for the 2020-2021 school year. Mrs. Bolden respectfully declined because she had already served her term. Mrs. Richardson nominated Ms. Edwards to serve as Chair for the 2020-2021 school year. Ms. Edwards accepted the nomination. Floor opened for nominee to explain why she was the best candidate for the position. Ms. Edwards explained to the members why she felt she was the best candidate. A motion was made by Dr. Payne for Ms. Edwards to serve as chair and second by Mrs. Bolden, members voted for the Chair and the results showed 9 approved, 0 declined and 0 abstained. Second, Dr. Payne nominated Mrs. Price to serve as the Vice Chair. Mrs. Price was given the opportunity to speak on why was the best candidate for the position. A motion was made by Mrs. Richardson for Mrs. Price to serve as the Vice Chair, Mrs. Bolden second the motion, members voted and the results were 9 approved, 0 declined, and 0 abstained. Next, Ms. Kristin nominated Mrs. Bolden to serve as Secretary. Mrs. Bolden accepted the nomination. Mrs. Bolden explain why she would best serve as Secretary of the GO Team. Mrs. Price made a motion for Mrs. Bolden to serve as the Secretary, Ms. Edwards second the motion, members voted and the results showed 9 approved, 0 declined, and 0 abstained. Finally, Dr. Payne nominated Ms. Kristin to serve as the Cluster Representative. Ms. Kristin accepted the nomination and made her speech as to why she would best represent this position. A. **Budget Updates: Principal's Report – Adjusted Budget Presentation**

**Eliminated:** Stipends  $\$1500 \times 6 = \$9,000$ ; SAMS Conference =  $\$4,950$ ; Admin Travel =  $\$4,500$ ; Teacher Travel =  $\$4,500$

**Reduced:** Teacher Substitute days from 13 to 8, \$41,834 to \$25,744; Para Substitute days from 8 to 5 days \$5,064 to \$3,165; Teacher Tutor from 15 hours for 31 weeks to \$27,667.50 to 12 hours for 30 weeks \$21,420; Field trips reduced from \$5,000 to \$2,000; Reduced textbooks to \$5,000.

**Added:** \$4,036 to be added to supplies from \$20,000 to \$24,036 and Web Based Subscriptions from \$0 to \$13,300.

**Enrollment** - The projected enrollment for Cleveland Avenue Elementary was 304 students. As of the 15<sup>th</sup> day of school (September 14, 2020), Infinite Campus reflected the actual enrollment for Cleveland Avenue Elementary was 261 students. Since Cleveland Avenue elementary was under projected enrollment by 43 students, a reduction of \$190,806 would be required (at the SSF base per pupil amount of \$4,437) IF we were to make adjustments based on this data. **We are about 40 students short for kindergarten.**

**Leveling - Partial Restoration of School Reserve:**

In August, the Board approved 1% of the SSF total to be returned to schools. Cleveland Avenue Elementary will receive \$30,624. These funds will be used to offset any losses experienced during the leveling process, with any remaining funds being disbursed at the same time.

- IV. Announcements:** Ms. Kristin would like to do something special for Teachers during Teacher Appreciation Week. **Amendment to Ms. Kristin's announcement: Ms. Kristin wanted to do something special for teachers for Return to School in October, not the traditional Teacher Appreciation Week.** Dr. Payne will check with her Leadership Team to discuss ideas. Since Ms. Gipson had to attend another meeting, Mrs. Bolden shared her message "We're doing great!"
