### Princpal's Report

- Principal's coffee Samantha Clay from district testing office. This was recorded topic was the Milestones
- Please vote for Go Team, ballots just opened yesterday
- Use of the Inman Building Mary Lin didn't make any official comments except for one statement from the Inman Park Neighborhood Association Education department - that they are neutral
  - Some SPARK community groups are advocating for SPARK dual campus. They
    wanted to know if the Lin Go Team or any other group would support that option.
  - Why are Mary Lin's numbers included in one option but not others (SPARK numbers would be too low without IP. Each member of the GoTeam shared opinion and 100% preferred that Mary Lin stay as-is with Inman).
  - Vote is in May
  - Maybe we should do a straw poll
  - o 2 options:
    - Survey Inman is a K-5 and Inman Park leaves
    - Spark is a dual campus and IP stays at Lin
  - Lin is at 82% capacity
  - Is funding affected if we lose IP students? Yes, based on the number of students who are enrolled in your building. \$4500 funding per student, 159 kids would be lost from IP.
  - How would the specials teachers be affected? We may need only 1 coach instead of 2 if IP leaves Mary Lin. Not sure how this would affect our specials teams.
  - If IP doesn't go to Spark and Spark is under enrolled, could Spark get a pre-K.
     Or if IP does leaves, can Mary Lin get a pre-K? Pre-K is not part of the enrollment counts for student-based funding.
  - Why are people saying that IP kids should go to Spark if they're under enrolled this isn't a good reason? - The question is more, why is Mary Lin included in one solution and not the other.
  - Mary Lin parents have been underrepresented in the survey on the future of the Inman Middle building.

  - o All 4 schools came up with options survey, then APS did away with the 4-5 idea
  - Last week the GoTeam stated that they unanimously feel Mary Lin should not be involved in either of the 2 options currently being considered.
  - Spark asked Lin to weigh in, so we're trying to determine how best to solicit opinions from our community. The survey is just collecting info on how people feel about the options.
    - 158 responses, 78.5% support dual campus/lin untouched, 21.5% support IP going to Spark.
    - 73.4% said they prefer Lin to be left out of the discussion
    - The info collected will be shared with the Lin community
    - April 13th GoTeam meeting, RB from the 14th watch/read these things if you want to know more about the options
    - Survey closes Friday.
