- i. Enrollment 640 scholars are enrolled plus 10 additional attending Atlanta Virtual Academy

- iii. COVIS response team ensuring isolations and effective communication is consistent. Deep cleaning occurs within 24 hours of notification. Classes are moved when needed.
- iv. All adults, children, and visitors must wear a mask. Physical distancing to the best extent possible. Approved scholars are tested every Monday. Mandatory testing will commence after Labor Day for every adult, twice a week. Assigned seats to allow to accurate contact tracing. Limited sharing of supplies and technology. *How is lunch or auditorium type events handled?* We do not have auditorium events. Large events are housed outside to maximize space and distancing. Only two grade levels eat lunch in the cafeteria (4<sup>th</sup> and 5<sup>th</sup>). Teachers are also encouraged to take their classes outside to lunch.
