1	 Suggestion to change traffic patterns with one way streets (maybe only during drop off and pick up times?); APS transportation can work on this but haven't been successful with those types of changes There are TSPLOST improvements for the Dobbs/Boulevard/Irwin intersections pending Bus and parent traffic will be separate; parents will circle block to get east bound on Dobbs for drop off at north side of site (building front), stacking on Howell (parents may drop off on block where ever convenient); buses in new midblock street to south of building APS has not done any traffic studies outside of immediate site boundary Encourage GDOT Safe Routes to Schools program review; Beltline accessibility to school; path to Walden Fields APS has no funds for off-site improvements Walden Field facilities to the west are likely too far to use during school day for athletics; the fields on site will be maintained by APS APS assumes bus usage will increase at this site; some Inman parents, Design Committee members disagree Limited number of parking is encouraged (do not exceed APS standard – "handle the school needs"); Both MLK and Inman Park districts are against extensive parking 	ACTION BY	STATUS
