### Playground updates

### 2) Mrs. Briscoe shared updates on playground/safety

- Candler Park Festival weekend kids wrote inappropriate messages on chalk board. It was not considered vandalism, because there was no permanent damage. As a result, APS is going to updated the cameras to scan the playground. Legally the fence/gate has to be locked during school hours.

- Student left Mary Lin's campus by using the back gate of the playground. As a result, we now have playground post on the playground and we have developed a missing child safety drill.

## 3) Team discussion on security of playground:

- Keep open for public use during the weekend and school breaks/locked during weekdays.
- Suggestion to hang a sign outside of the playground with rules of the playground and warning that the area is 24-hour video camera monitoring. No dogs
- Galit and Melanie are going to draft a sign and submit to APS for approval
- Habitat gate: Should be open for people to reach garden beds
