New Business

Review and vote on proposed amended budget

Teacher Allotments - the budget allotted \$250 per teacher (\$12,500 total), PTA is hoping to increase this to \$350 per teacher as the school partner program has been so successful.
PTA would like to increase Ms Benton's and Ms Briscoe's to \$1k from \$750 (Sharyn Briscoe uses her allotment for Professional Development, Mary Benton typically uses her allotment to donate something back to school, such as the very popular sound system in cafeteria). The PTA is currently working through the reimbursement process.

- Sunshine Club Mary Lin staff pays dues to be in the club and receive benefits, such as sympathy flowers, baby showers/gifts, and parties. PTA would like to add \$500 to supplement their budget
- Educational Enrichment new line item PTA helped Ms Briscoe pay for a field trip and we need a place to put it in the budget
- Small Tall Ball Mary Lin traditionally held separate events for boys and girls Linsanity and Small Tall Ball
 - The events were kept the same last year, but this year we are trying something new. There will be 2 identical events that will include both boys and girls: one for K-2nd grade, and one for grades 3-5
 - PTA would like to move \$1k from Linsanity to the Small Tall Ball fund, and split the total \$3000 between both events (\$1500 each)
- DIRECTORY COSTS PTA needs to increase this from \$750 to \$1400
