Subject: Important COVID-19 Updates for APS Employees

This past Friday marked the end of the first week of closure of Atlanta Public Schools (APS) for teleschooling and teleworking, and I want to thank each and every one of you for the role you played in helping our District maneuver successfully through the unknown. It was impressive to watch staff across APS collaborate, innovate and problem-solve last week. It goes without saying that there were a few challenges along the way, but there was nothing we couldn't overcome. I am looking forward to this week being even more successful with all of you by my side!

### **Closure Dates, Spring Events, Community Meetings, and Graduation**

We've previously shared that APS would remain closed for teleschooling and teleworking through at least March 31 and possibly through Spring Break (April 6 - 10) and beyond. Given recent guidance from health officials and governmental actions from various elected officials, we anticipate that APS will remain closed at least through Monday, April 13 and possibly beyond. This will mean that we must continue to collaborate, innovate, and problem solve in this new extended virtual learning and working environment. I ask for your continued patience as we work our way through our new norm for the next several weeks. As a reminder, all previously planned community meetings and events have been cancelled during our closure. No final decision on graduation or other major District events has been made at this time. We are evaluating future events on a case-by-case basis, and will make decisions in the near future.

# **COVID-19 Update**

As of now, there remains one confirmed case of COVID-19 in APS. As I shared in my memo to you on <u>March 19</u>, that one confirmed case yielded no exposure to students and there was no close contact with employees based on the Fulton County Board of Health's investigation. Please continue to practice the preventative measures provided by health officials to stop the spread of COVID-19. Those measures and other resources can be found on our <u>coronavirus webpage</u>.

I am thankful for the number of APS employees who have volunteered to help distribute food and devices to our families, or whose roles as food workers, safety resource officers, facilities team members, and bus drivers have involved working at our food distribution sites. We couldn't have provided 30,000 meals a day to our families or put more laptops and devices into the hands of our students last week without your support. You are an incredible team, and I want to ensure that you stay healthy as well. I spoke recently with officials at the Fulton County Board of Health about whether there are any health risks associated with our device distribution or our food and nutrition efforts, including food prep. Health officials said that for now, so long as people are not sick (especially not coughing) and are maintaining social distancing, we should still be okay for providing any distribution-type services for as long as we can. The only absolute no-no was coming to work sick. As we've stressed since the onset of COVID-19, please stay at home if you don't feel well, practice social distancing and all of the measures that prevent the spread of this virus.

#### APS District Town Hall: A Virtual Conversation, Thursday, March 26

I know that parents and staff have a lot of questions for APS given our closure for teleschooling and teleworking. ### State Suspension of Assessments, Evaluations

State School Superintendent Richard Woods on Monday, March 16, announced the suspension of state assessments, including the Georgia Milestones, as well as teacher evaluations and attendance accountability measures until further notice. Mr. Woods said school leaders need to be focused on the safety of students and staff and on creating flexible ways to keep virtual learning going. That's exactly what we plan to do.

While this transition to a long-term teleworking environment has required amazing work by many people and flexibility from all of us, it has not come without challenges. We are actively working to secure more technology devices for employees who need them, and we are working with internet providers to obtain higher quality, low or no-cost internet service for employees working from home. ### Whitefoord Health Clinics Still Open, COVID-19 Testing Available for APS Employees

Whitefoord Clinics will be open again this week, March 23-27, and observe the <u>same hours as</u> <u>last week</u>. The clinics will continue to see routine and urgent health needs. They will also begin offering telehealth behavioral health appointments for children and adults this week. There are some visit types, such as immunizations or strep throat tests, that we can be done while patients wait outside in their cars.

In addition, Whitefoord can provide COVID-19 testing to APS staff, while supplies last. Just identify yourself as an APS employee to the phone screener so you can be prioritized. Whitefoord Health clinics have established this hotline number, (470) 427-2634 ext. 123, to assist patients with respiratory symptoms, and testing for COVID-19 and flu.
