MLA Format

Each entry on the Works Cited Page should include the basic elements listed in this order: Author. Title of Source. Title of Container(magazine, journal,etc.), Other Contributors, Version, Number, Publisher, Publication date, Location of source (URL or DOI, page number, location of museum, etc.). Follow the order and punctuation shown in each example. Note: the date of access for online information is optional. Consult your instructor.

Book

Last Name, First Name. *Title of Book*. Publication Date. Diaz, Junot. *The Brief Wondrous Life of Oscar Wao*. Riverhead Books. 2008. In-text citation: (Diaz 156)

Work in an Anthology

Last name, First name. "Title of Essay." *Title of Collection*, edited by Editor's Name(s), Publisher, Year, Page range of entry.

White, Evelyn C. "Alice Walker's Childhood Sense of Betrayal." *Women's Issues in Alice Walker's The Color Purple*, edited by Claudia Durst Johnson, Greenhaven Press, 2011, pp. 24-30.

Article in a Magazine.

Author(s). "Title of Article." Title of Periodical, Day Month Year, pages.

Gass, William. "A Body of Work." Art Papers, July/August 2015, pp. 41-45.

Article in a Scholarly Journal or Magazine with Vol/Issue

Author(s). "Title of Article." Title of Journal, Volume, Issue, Year, pages.

Blow, Joe. "This is a Test" Time, vol. 187, no. 15, 2016, pp. 30-35.

Harbach, Meredith Johnson. "Sexualization, Sex Discrimination, and Public School Dress Codes." *University Of Richmond Law Review*, vol. 50, no. 3, 2016, pp.54-70.

Newspaper Article

Cite a newspaper article as you would a magazine article, but note the different pagination in a newspaper. If there is more than one edition available for that date (as in an early and late edition of a newspaper), identify the edition after the article title.

Article in a Common Reference Book (encyclopedias, dictionaries).

Personal Interview

List the person interviewed; the label Personal interview, or E-mail interview; and the date the interview view took place.

Internet Sources Use the following format:

Author. Title. Title of container (self contained if book), Other contributors (translators or editors), Version (edition), Number (vol. and/or no.), Publisher, Publication Date, Location (pages, paragraphs and/or URL, DOI or permalink). 2nd container's title, Other contributors, Version, Number, Publisher, Publication date, Location, Date of Access (optional)

Article in a Web Magazine

Journal Article in a database: Cite articles from online databases (e.g. LexisNexis, ProQuest, JSTOR, ScienceDirect) and other subscription services as containers. Thus, provide the title of the database italicized before the DOI or URL. If a DOI is not provided, use the URL instead. Provide the date of access if you wish.

<u>A Broadcast Television or Radio Show:</u> "Title of Episode." *Name of Series or Program.* Network Name, Station Name, City, Broadcast date.
