- **The Atlanta Public Schools' Facilities Department is requesting quotes to provide a hazardous building material survey for the purpose of renovating at the Parks Building.**
- **The survey should be written to show detailed quantities and locations of all hazardous building materials for the purpose of competitive bidding for abatement firms.**
- **The survey should include, but not limited to, ceiling tiles and glue dots, floor tiles and mastic, plastering, hot water supply piping, HVAC piping, mechanical room equipment, florescent bulbs, ballast, mercury thermostats fire rated doors, etc. Roofing material will not be a part of the scope.**
