Eligibility for North Atlanta's Dual Enrollment Program requires students to complete each of the following steps by the deadlines indicated below. Students who do not follow ALL the NAHS DE application procedures and deadlines will NOT be eligible to participate in the DE program, even if the college has accepted the student.

Once students have completed Step 8, they will receive an invitation to attend a mandatory dual enrollment registration session in May. This is when accepted students will register and be approved for their DE college classes and finalize their NAHS class schedule.
