

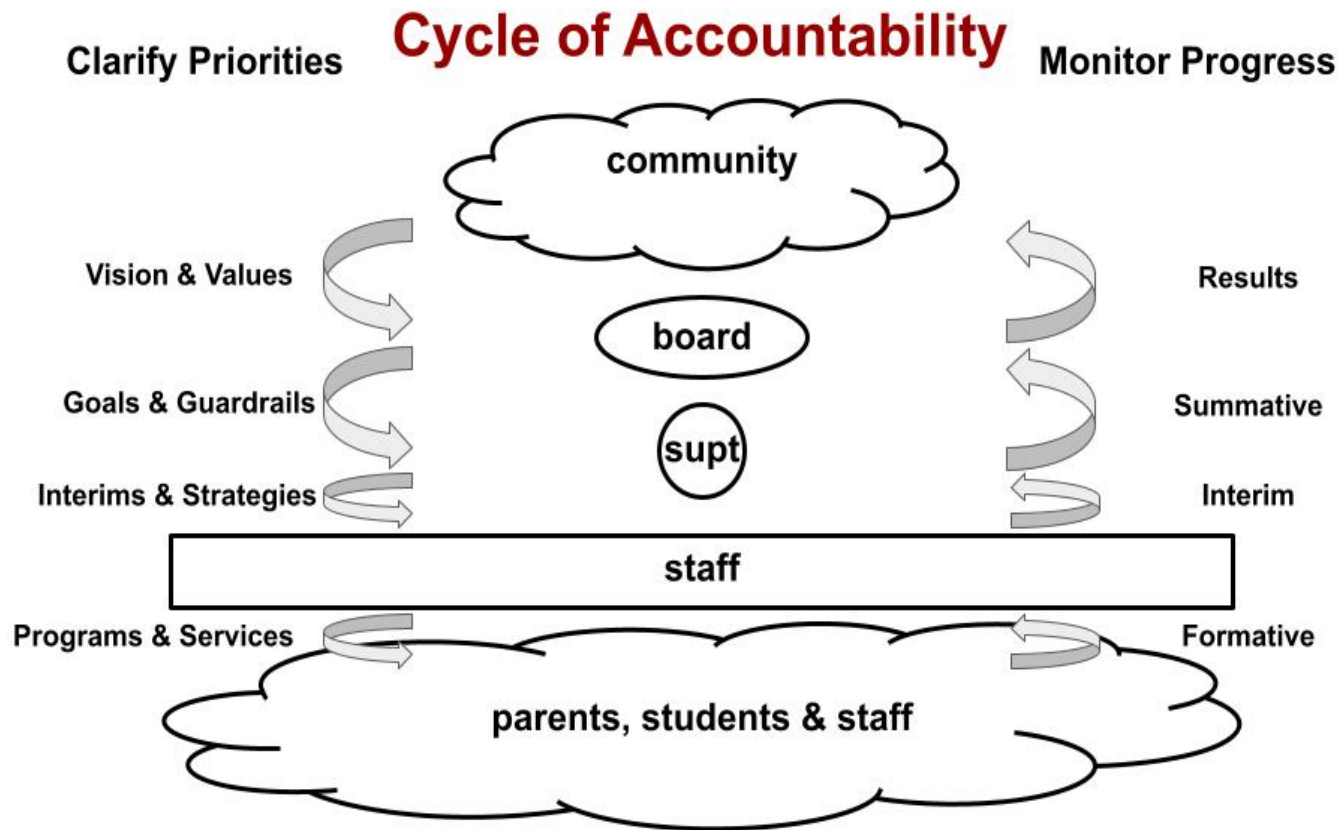

# APS Goals



## Goals



### Goal 1: Literacy Proficiency

The percentage of students in grades 3–8 scoring proficient or above in reading, as measured by the Georgia Milestones, **will increase from 31.2% in August 2022 to Y in August 2026**



### Goal 2: Numeracy Proficiency

The percentage of students in grades 3–8 scoring proficient or above in math, as measured by the Georgia Milestones, **will increase from 26.0% in August 2022 to Y in August 2026.**



### Goal 3: Post-Graduation Preparedness

Increase the percentage of high school students who graduate prepared for their next step as demonstrated on a multi-dimensional assessment based on the Profile of a Graduate.



### Goal 4: College and Career Readiness

The percentage of high school students who score at the college and career readiness level on career pathway assessments, IB, AP, Dual Credit, ACT or SAT, work-based learning, or entering TCSG/USG without needing remediation **will increase from 27.1% in October 2022 to 59.3% by October 2026**



# APS Goals



## Goal 1: Literacy Proficiency

The percentage of students in grades 3–8 scoring proficient or above in reading.

- The percentage of students in grades 3–5 scoring Proficient or Distinguished on the Milestones End of Grade exam **rose to 37.5%**, surpassing the 2019 high of 37.1%.
- Middle school ELA scores have not returned to pre-pandemic levels, but there was an **improvement** from 31.8% in 2023 to 33.4% in 2024.
- **Substantial disparities** in Milestones proficiency rates between Black and White students persist. Results range from 84% proficient for White students to 23% proficient for black students in English Language Arts.



## Goal 2: Numeracy Proficiency

The percentage of students in grades 3–8 scoring proficient or above in math.

- **Year-over-year proficiency rates increased** from 34.1% in 2023 to 36.7% in 2024, but the percentage of students in the "Beginning" category is still 5+ points higher than in 2018 (32.6% vs. 27.4%).
- 8th grade EOG proficiency rates reached their **highest level** since 2015 in 2024.
- 36.8% of Grades 3–8 remain in the **low achievement and low growth category**

# APS Goals



## Goal 3: Post-Graduation Preparedness

Increase the percentage of high school students who graduate prepared for their next step.

- **Performance increased** from FY23 in all but one College and Career Readiness indicators on CCRPI, including subgroups.
- The percent of graduating students who enrolled in a post-secondary institution **ranges** from 26% to 84%



## Goal 4: College and Career Readiness

The percentage of high school students who score at the college and career readiness level on career pathway assessments, IB, AP, Dual Credit, ACT or SAT, work-based learning, or entering TCSG/USG without needing remediation.

- Over **48% of Cohort 2024 students completed** at least one Advanced Placement, International Baccalaureate, or Dual Enrollment course.
- Access to programmings continues to **vary** across schools and clusters.

# APS Guardrails



## Guardrails

### Guardrail 1: Equity

The Superintendent will not allow inequitable treatment of students as measured by student academic outcomes, discipline occurrences, and/or resource allocation.

*Measure: The percentage of district divisions and schools aligning their efforts and resources with the APS Strategic Equity Framework*

### Guardrail 3: Culture & Climate

The Superintendent will not foster or allow a culture of fear, intimidation, or retaliation, or an unwelcoming environment.

*Measure: The percentage of staff, students, and parents who indicate that the district has a welcoming environment free of fear, intimidation and retaliation*

### Guardrail 2: Stakeholder Engagement

The Superintendent will not make major decisions or bring major recommendations to the Board without first implementing a stakeholder engagement strategy, including students, parents, teachers, staff, governance teams, and community members.

*Measure: Increase the percentage of stakeholders who agree that they are involved in the decision-making process*

### Guardrail 4: Innovation & Accountability

The Superintendent will not allow struggling schools to be without: a comprehensive needs assessment; supports aligned to that assessment; and, if the struggle persists for up to three years, a high impact intervention.

*Measure: The percentage of schools needing Tier 2 and/or Tier 3 support in the district continuous improvement model*

## Potential Areas (based on Fall Engagement)

Operational (transportation, facilities, safety & Security)

Subgroup (ethnicity, students with disabilities, english language learners, economically disadvantaged)

Unwelcoming Environments (Customer Service, engagement)

Disciplinary Practices (disproportionality)

Human Resources (teacher retention, high quality teachers, engagement), Governance (GO Teams, Board)

Whole Child (well-being, wraparound, student support)
