

Six probationary charter potential impacts

- Six charter schools (Centennial, KIPP WAYS, KIPP Soul, KIPP Vision, Kindezi O4W, Kindezi West) received conditional probation approval by Atl BOE: requires that each school "exits the Georgia Department of Education's support and improvement lists" by 26-27 SY
- If these six closed in June 2027, they would send back 2,892 students to neighborhood schools in 27-28 SY
- Positive impacts at 43 schools (+1,723 students, 35 ES, 8 MS): could soften closure stance at purple schools
- Negative impacts at 9 schools (+806 students;
 Overutilization in 27-28 SY), esp. Hope Hill ES, Howard MS, Hollis K-8





US Historic & Projected Enrollment (PK-12) Fall 2012 – Fall 2031



Georgia Historic Enrollment (KK-12): Fall 2003 – Fall 2023




Historic Enrollment (KK-12): APS and Clayton County Fall 2003 – Fall 2023
