**What is Title I?**

Coretta Scott King is identified as a Title I school as part of Every Student Succeed Act of 2017 (ESSA). Title I is a federal program that provides funding to local school districts to help ensure that all children in district Title I schools meet the state's high academic standards. Title I programs must be based on effective means of improving student achievement and including strategies to support parent and family engagement. All Title I schools must jointly develop with all parents and families a written family engagement plan.

**What is it?**

This is a plan that describes how Coretta Scott King Young Women's Leadership Academy will provide opportunities to improve family engagement to support student learning. Coretta Scott King Young Women's Leadership Academy values the contributions and involvement of parents to establish an equal partnership for the common goal of improving student achievement. **How is it developed?**

Coretta Scott King Young Women's Leadership Academy will provide full opportunities for the participation of parents with limited English, parents with disabilities and parents of migratory children.
